





# OVERVIEW OF THE VIETNAM DEVELOPMENT BANK

### 1. Establishment and development of VDB

- 1.1. The Vietnam Development Bank (VDB in abbreviation) was established in accordance with the Decision No. 108/2006/QD-TTg dated May 19<sup>th</sup>, 2006 by the Prime Minister on the establishment of the Vietnam Development Bank on the basis of reorganization of the Development Assistance Fund, to execute investment credit and export credit policies with operational term of ninety-nine (99) years upon effectiveness of this Decision. The organizational and operational regulations of VDB are in accordance with the Decision No.110/2006/QĐ-TTg dated May 19th, 2006 by the Prime Minister. On March 30<sup>th</sup> 2007, the Prime Minister issued the Decision No. 44/2007/QĐ-TTg on financial management regulations at VDB.
- **1.2.** On September 3<sup>rd</sup> 2015, the Prime Minister issued the Decision No.1515/QĐ-TTg on organization and operation regulations of VDB according to which:

VDB is a policy bank operating under the model of single member limited liability company (OPC) with 100% state-owned charter capital.

VDB is a legal entity defined in accordance with Vietnamese laws with its own charter capital, stamp and account registered at the State Bank of Vietnam, State Treasury, and at domestic and foreign commercial banks; VDB is allowed to participate in the interbank payment system and provide payment services as stipulated by law provisions.

The State is the owner of VDB. Government manage in a unified way, rights and duties arising from VDB's state-ownership. The Prime Minister, as assigned by the Government, exercises in person rights and obligations of the owner or authorizes the Ministry of Finance to certain of them on his behalf. As assigned by the Government or by authorization of the Prime Minister and according to VDB Charter's provisions, the Ministry of Finance shall exercise certain ownership's rights and obligations. The Board of Directors are the direct representative of the Sate owner at VDB and have decision on issues related to VDB according to the authorization procedures prescribed in the VDB's Charter.

The legal representative of VDB is the General Director.

VDB operates for non-profit purposes in order to carry out the task of State policies credit and other tasks as stipulated by the Government or the Prime Minister;



The State budget shall compensate interest rate difference and management fee and guarantee VDB's solvency. VDB is exempted from government tax and obligations to State contribution. VDB has a compulsory reserve rate of 0% (zero percent) and does not have to make deposit insurance.

The VDB's charter capital is VND 30,000 billion (thirty trillion). Any charter capital change shall be decided by the Prime Minister at the proposal of the Ministry of Finance in compliance with requirements, tasks and capital adequacy ratio of VDB in each period.

The VDB's operation term is 99 years accounting from the effective date of the Decision No.108/206/QĐ-TTg on May 19<sup>th</sup> 2006 of the Prime Minister on the VDB's establishment.

### 2. Functions and missions of VDB

According to the Decision No.1515/QĐ-TTg dated September 3<sup>rd</sup> 2015 by the Prime Minister, VDB's functions and missions are as below:

#### 2.1. Fund mobilization

- a) Issue bonds guaranteed by the Government in accordance of law provisions;
- b) Issue bonds, promissory notes, certificates of deposit, valuable papers in VND in accordance of law provisions;
- c) Borrow from Vietnam Social Security, domestic and foreign financial and credit institutions in accordance of law provisions;
- d) Have access to loan allocation from the State Bank of Vietnam in accordance of law provisions and of guidance of the State Bank of Vietnam;
  - e) Take deposits entrusted by domestic and foreign organizations;
  - f) Mobilize other capital sources in accordance with laws provisions.

#### 2.2. Credit activities

- a) Provide loans in compliance with the State's credit policies; provide loans to programs and projects as assigned by the Government, the Prime Minister;
- b) Provide credit guarantees for SMEs to apply for loans from commercial banks according to the Prime Minister's regulations;
  - c) On-lend foreign loan capital of the Government;
- d) Provide short-term loans under Decisions of the Prime Minister in the principle that the State budget shall not cover the interest difference.



### 2.3. Entrustment and receiving trusted funds

- a) To be entrusted to mobilize capital and to provide loans in accordance of law provisions;
- b) To be trusted to manage credit guarantee funds for SMEs and local financial funds according to the local development objectives;
- c) To trust credit institutions to perform certain VDB's activities according to law provisions
- d) To trust or to be trusted to provide financial and banking services to clients in compliance with to law provisions.
- **2.4.** Participate in the inter-bank market; implement inter-payment; provide payment services, foreign exchange services and other banking services to customers; implement foreign exchange activities; participate in the domestic and international payment systems according to law provisions and to guidance of the State Bank of Vietnam.
- **2.5.** Perform other tasks as assigned by the Government or by the Prime Minister.



The gross domestic product (GDP) in 2018 increased by 7.08%, the highest growth rate since 2008. The scale of the economy in 2018 at current prices reached VND 5,535.3 trillion. Banking activities: Total means of payment had a rise of 11.34% (14.19% for 2017); fund mobilization of credit institutions had a rise of 11.56% (14.5% for 2017); Credit growth rate of the economy was 13.3%. Average interest rates of VND deposits were 4.3% -5.5% / year for maturity of less than 6 months, 5.3% -6.5% / year for those from 6 months to less than 12 months, and 6.5% -7.3%/ year for over 12 months. Short term loan average interest rate in VND was 6% -9% / year, and 9% -11% / year for medium and long term.

CPI in average in 2018 was 3.54% higher than the one of 2017, lower than the target set by the National Assembly. CPI of December 2018 increased by 2.98% compared to December 2017.



## VDB'S PERFORMANCE IN 2018

#### 1. Fund mobilization

VDB has mobilized VND 23,691 billion of term capital for 2018, of which bonds issuance were VND 16,545 billion, representing 95% of the plan assigned by the Prime Minister, basically meeting with disbursement requirements for projects, loans repayment and other fund uses.

#### 2. Investment Credit

Disbursements for projects in implementation was VND 2,580 billion, collection of principal VND 12,856 billion, of interest VND 4,243 billion. Outstanding balance as of December 31th, 2018 was VND 81,535 billion.

### 3. Export Credit

In compliance with the Prime Minister's directives, VDB has completely rescinded new export financing. The principal collection of export credit was VND 1,294 billion in 2018, interest collection VND 115 billion. The outstanding balance for export credit was VND 3,619 billion as of December 31th, 2018.

## 4. ODA and Vietnam government oversea investments

The Ministry of Finance and VDB have signed 05 power of attorney contracts to manage ODA funding loans amounted to approximately USD 253 million and 04 credit contracts to on-lend from ODA funding sources.

In 2018, ODA disbursements were VND 4,192 billion, principal collection of VND 11,761 billion, interest and principal collection on behalf of the Ministry of Finance was of VND 3,564 billion, and VDB's on-lending fee of VND 246 billion. Outstanding balance as of December 31th, 2018 was VND 151,506 billion.

## 5. Post-investment subsidies and trusted funds management

- Post-investment subsidies: The actual accumulating amount was VND 530.5 billion as of December 31<sup>th</sup>, 2018.
- Loans from trusted funds: Outstanding balance was VND 401 billion as of December 31th, 2018. Trusted fund management fee collected was VND 2.1 billion in the year.
- Disbursement for trusted funds: The total disbursement from the beginning of the year to December 31<sup>th</sup>, 2018 was VND 91 billion. Entrusted fee collected since of the beginning of the year: VND 0.196 billion.




- Management and monitoring of disbursement for Son La Hydropower Project: disbursement of VND 436 billion for Son La Hydropower Resettlement Project (accumulated disbursement since the beginning is VND 25,136 billion.); disbursement for flood preventing road construction project was VND 0.111 billion (accumulated disbursement since the beginning is VND 1,011.8 billion).

#### 6. Guarantee for SMEs from commercial banks loans

VDB has rescinded to sign and issue new guarantees in accordance with the direction of the Prime Minister. As of December 31<sup>th</sup>, 2018, loans commitment amount by credit guarantee certificates in valid was VND 1,051 billion; loan principal balance at commercial banks was VND 571 billion; Interest to be paid at commercial banks was VND 499.7 billion. There was no debt repayment in 2018. Obligations to be fulfilled as of December 31<sup>th</sup>, 2018 was VND 639.7 billion.


